On consequence of further extension of last date of admission in PG courses upto 09.11.2022 conveyed by Endst. No. UCB/2022/4552-4581 dated 04.11.2022, the schedule of submission of online Registration/Continuation Return on university web portal for the students admitted in PG Programmes for the session 2022-23 is extended as under:

Last Date of admission in PG courses	Normal Last date of submission of online Registration/Continuation Return without fine (1st 20 days from the date of last date of admission) (Last date of admission + 20) (ii)	Last date of submission of online Registration/Continuation Return with late fine of Rs. 100/- per student per day. Arts/Commerce 09.11.2022	29.11.2022	19.12.2022	No Registration Return/Continuation Return will be entertained after 40 days. i.e. after the last date mentioned in previous column (iv). However, the Vice-Chancellor may consider to allow/ to admit the Registration Return/Continuation Return as a special case, with additional fine, keeping in view the genuineness of reasons submitted by the Principal of the college concerned.
