Annexure-B

PART-C: BASIC CONDITIONS FOR A TRUST-DEED

In the case of a College founded by individual donors, the following basic conditions for a Trust deed shall be observed unless the Management is vested in Societies registered under a Government Act:

(Sub clause(d) of Clause-4 appearing at page-52 of Ordinance – XVI of Kurukshetra University, Kurukshetra, adopted by Guru Jambheshwar University of Science and Technology, Hisar Calender Volume- I, 2009)

- i) That the founder of the Trust is the sole absolute owner of the property endowed;
- ii) That the trust is created by regularly registered deed to be approved by the Executive council;
- iii) That the founder permanently and unequivocally divests himself, his heirs and executors, of all interests in the property endowed;
- iv) That the endowed property is made to vest permanently and absolutely in the Trustees collectively;
- v) That the Board of Trustees- consists of at least seven members of whom at least five are independent members who are not in any related to or dependent upon the Founder of the Trust;
- vi) That in case of future vacancies in the Board, nominations are made by the Board and not by the Founder and such nominations are forthwith reported to the Vice-Chancellor;
- vii) That all buildings included in the Trust are sufficiently insured against fire;
- viii) That copies of the proceedings of the Board and a statement of the annual income and expenditure of the Trust are supplied to the Vice-Chancellor;

ANNEXURE-C

PART-D: SOME OTHER IMPORTANT CLAUSES TO BE ADHERED

(From the Ordinance-XVI of Kurukshetra University, Kurukshetra, adopted by Guru Jambheshwar University of Science and Technology, Hisar Calendar, Volume I, 2009)

- In case of granting affiliation to a new College in rural area the distance between one rural College and another rural College should not be less than 15 k.m. However, if the existing Colleges have attained the strength of 800 students then the Executive Council may relax the condition of 15 k.m. distance provided the physical facilities in the existing Colleges do not remain unutilized. The above condition may be relaxed for starting purely Girls College in rural area.
- ii) In urban area, no new College should be started unless all existing Colleges have attained the maximum strength of 1000 students. However, if there is no Girls College in that town then this condition will not be applicable for starting a purely Girls College.
- iii) The recognition/affiliation of the college, having regard to the educational facilities provided by other Colleges in the same neighborhood will not be injurious to the interest of education.
- iv) No college affiliated to the University shall discontinue instruction in any Faculty/Course/Subject without the prior permission of the University.
