3. The annual Academic Audit of the colleges having permanent affiliation, where annual inspection is not carried out, will be carried out every year.
4. The periodic inspection of the colleges having permanent affiliation shall be carried out at the interval of every three years.
5. The course Extension fee of Rs. 20,000/- (Twenty Thousand Only) per course for introduction of new courses in Engineering/Management Colleges/Institutes will be applicable from Academic session 2018-19. This fee will be charged separately for each new course till the extension of course to its full duration and it will come into force with the introduction of the course. It will automatically be stopped once the course is extended to its full duration.
6. The annual inspection fee as applicable per college/course (Arts/Science/Commerce, B.Ed, Law Colleges etc.) and as decided by Executive Council vide Resolution No. 39 of its meeting held on 15.06.2016 for Engineering/Management Colleges will be recharged from the college/institute in case re-inspection of a college is made on account of not meeting the eligibility criteria for grant of continuation in annual affiliation or any other valid reason as recorded by the Inspection Committee in its Inspection report.
7. To discourage the wrong admissions by a degree College (Arts/Science/Commerce) over and above the sanctioned intake, a penalty of Rs. 1,00,000/- (One Lac) per student ceiling to Rs. 10,00,000/- (Ten Lacs) per course on a college for making admissions over and above the sanctioned intake shall be imposed. Such admissions shall be made regularize only on the merit of the case as decided by the Vice-Chancellor subject to the fulfilment of the Infrastructural facilities as well as payment of penalty amount.

8. The Executive Council has further approved that the annual continuation fee and annual Inspection Fee of KUK, if any, as per ordinance XVI of KUK Calendar-2009 Vol-I adopted by this University shall be applicable in respect of affiliated degree colleges of Art/Commerce/Science and Law Colleges for the session 2017-18 only.


